A meter printed delivery ticket will be left or mailed to above address each time a delivery is made. You agree to pay in full within 20 days of delivery. Accounts over 45 days are subject to removal from automatic delivery and changed to COD without written notice.
2. Finance Charges will be assessed on balances 30 days overdue @ 2% monthly, 24% Annually. Fifteen (15) cent per gallon discount if balance is paid within 10 days of delivery. Bounced checks charged \$25.00, loss of discount, customer pays all legal fees.
3. We are not responsible for damage of loss caused by failure to make delivery due to labor shortage, strikes or to conditions beyond our control. If we do not deliver oil as a result of default, we will not be liable for any damages in either direct or indirect manner.
